**INTENT:**

The Roosevelt Irrigation District ("RID") intends to procure **Electrical Equipment and Installation Services** associated with the RID Reclaimed Water Exchange Program ("RWEPP"). This project involves rehabilitating and equipping existing wells owned by RID and equipping new replacement and recovery wells.

The RWEF includes the following key components:

Electrical Equipment Purchasing and Installation: Purchasing and Installing new equipment to improve operational efficiency and monitoring accuracy.

Electrical Equipment Installation and Rehabilitation Services: Equipping wells in the vicinity of an underground storage facility to enhance efficiency and capacity.

The plan includes an estimated timeline of approximately two years, covering the well rehabilitation and the installation of new, more efficient equipment. Wells range from 700-1,000' in depth and are from 20'-24" in diameter. It is expected that each well will be equipped and tested under these contracts.

The Arizona Water Infrastructure Authority ("WIFA") has formally agreed to provide funding to RID for the RWEF. This generous financial support is contingent upon the specific ARPA terms and conditions outlined in the agreement between WIFA and RID.

**BID COMMENTS:**

RID may award multiple contracts for Electrical Equipment Purchasing and Installation Services in the vicinity of an underground storage facility to enhance efficiency and capacity.

**BID SUBMISSION:** Vendors must view or download all attached forms prior to submitting bids.

**MOUNTAIN STANDARD TIME:** Times listed for pre-bid meetings, Q and A, and Bid Close are in Mountain Standard Time (MST).

**EVALUATION AND AWARD:** Award is made at the sole discretion of RID. RID reserves the right to award in full or in part to a single vendor or multiple vendors.
